RELEASE OF LIABILITY AND FULL ASSUMPTION OF RISK

In consideration for the privilege of entering upon the private property of The Hartford Gun Club, Inc. for the purpose of participating in shooting events or attending same as a spectator only, as such events are held on the PREMISES OF THE HARTFORD GUN CLUB (hereinafter referred to as "HGC"), located at 157 South Main Street, East Granby, Ct. I hereby acknowledge and understand that the shooting sports, including the shotgun shooting sports, involve inherently dangerous activities related to firearms and the recreational use and enjoyment thereof. In full recognition of said inherent dangers in the use of firearms and that any sport involving firearms is inherently dangerous I hereby agree to abide by all posted rules and regulations enacted and displayed and/or distributed to me by HGC and further assume all risks to my personal safety and personal property which may arise by or be related to the discharge of any firearm, whether shotgun, rifle or pistol, accidental or otherwise, OR flying targets OR flying target pieces encountered by me while on the premises of HGC whether related to the event for which I attend or not so related. Should I be injured or should I directly or indirectly cause injury to any other person as a result of my participation in any shooting event as participant or merely as a spectator thereto, I DO HEREBY RELEASE AND HOLD HARMLESS AND AGREE TO INDEMNIFY THE HARTFORD GUN CLUB, INC. AND ITS EMPLOYEES, OFFICERS, BOARD OF GOVERNORS, ITS AGENTS AND /OR SERVANTS AND ALL HGC MEMBERS FROM ANY INJURY CAUSED BY MY ACTIVITIES, EITHER DIRECTLY OR INDIRECTLY. I FURTHER HEREBY RELEASE SAID HGC, ITS EMPLOYEES, OFFICERS, BOARD OF GOVERNORS AND ANY AND ALL MEMBERS, AGENTS, SERVANTS FROM ANY LIABILITY OF ANY KIND INCLUDING CLAIMS FOR DAMAGES FOR LOSSES WHICH I SUSTAIN FROM PERSONAL INJURY OR PROPERTY DAMAGE WHILE I AM LOCATED ON THE PREMISES OF HGC WHICH ARE CAUSED BY THE ACTIVITIES OF OTHERS.
